



World President's Address



UNIQUE in every sense of the word...

Dr. Don Johnson, ICD President -at- Large, addresses the European Section

e are here today to conduct a very serious and solemn ceremony. We are here to honor certain individual fellows who have continued to serve this College, and our profession, above and beyond the call of duty. Upon those Fellows we will confer the degree of Master of the College.

We are also here to officially welcome into the International College of Dentists those individual dentists who have accepted our invitation to Fellowship. The opportunities and obligations of Fellowship will be explained as we proceed though this ceremony, and will reach completion by the placement of the Key to the College and the extension of the Hand of Fellowship. Be reminded, however, you should look upon this occasion as a beginning, not as an end.

As Jan and I have traveled the globe this year, we have had an opportunity to see a true cross section of the International College of Dentists, and to meet some very memorable people. From the dental student who was thirsting for knowledge and begging for advice on how to find success, to an individual who is a patent holder of one of the major bonding agents in use today, and another who is the developer of a device that is in daily use by dentists around the world. Now I have had the opportunity to spend a few days with the friendly faces of the European Section.

To date, we have been once around the world, twice in Asia, and for the second time now in Europe, not just seeing the sights, but seeing the ICD from the grassroots.

I have been listening to your deliberations, trying to understand your needs, and searching for the answer as to how this College can better serve the needs of our profession.

It is a pleasure to be in an area where English is both spoken and understood, although some of you may question whether my version of English is pure, or acquired.

You will get no debate on that issue from me because we both know that English did not originate on my side of the Pond. How it got converted into, or from, some of the words we have seen along the roadside here in Wales is another story.

The dental practices and institutions that support our lifestyles are the result of skilled and dedicated men and women who worked together to develop the profession we enjoy today. Do we not have a responsibility to protect that effort and to continue that progress?

I believe we do, that is the position of this College, and that

is the challenge associated with the honor of Fellowship.

Candidates; some of you may be under the misconception that you are "joining" the ICD. Nothing could be farther from the truth. You do not, and you cannot, "join" this organization. If a dentist has exhibited the qualifications for Fellowship, and if his or her peers have recognized those efforts to the extent that a Fellow of the College has sponsored that person for Fellowship, as is the case for each of you, then Fellowship is offered. Because you have satisfied the demanding qualifications for Fellowship, you are here to receive a well deserved honor. You are important to this College. You are important to Dentistry.

While we, the present Fellows of this College stand before you today, and will conduct this ceremony, you are the ones who will someday replace us and receive the torch of leadership. Some of you will even become responsible for this preeminent international dental organization and the safekeeping of the profession.

I thank you for your attention and I welcome you to the Fellowship.


A look back at the

Dental Education in Europe From Barber Dentists to the Bologna Process

In the Middle Ages the Church and its monks were the most important agents of medical education. Only monks read Latin, the language of most medical texts which were preserved in monasteries.

Change came in the XIII Century when the first European medicine faculties started teaching physiology, pathology, hygiene, anatomy, therapeutics and Hippocratic aphorisms. Excluded from the curriculum was surgery, which was considered degrading. Consequently, doctors were prohibited from performing surgery, including dentistry which was allocated to barbers trained by a Master.

This article will look at the subsequent periods in the history and development of dental education in Europe through the experiences of representative countries with a view to the future status of cooperation among European nations towards the training of the next generation of dentists.

Experiences in Dental Education of Selected European Countries

France

The edict of 1699 signed by Louis XIV is responsible for the title of "Expert in Teeth", dental education and governmental recognition of the dental profession. Dentistry was restricted to the Parisian environs and to those who had satisfied examination by three masters of surgery of the College of Surgeons of Paris and granted with the title of 'expert'. Dentistry status was enhanced with the publication of Pierre Fauchard's 'Le Chirurgien Dentiste' in 1728, a valued compendium of the existing knowledge of dentistry. A century and a half later, the first dental schools were

established (1880s); first, L'Ecole Dentaire de Paris; followed by L'Ecole Dentaire de France. Both were private Parisian schools, unrecognized by the universities, each with the same entry and curriculum standard and each granting its own diploma title 'Chirurgien Dentiste'. In 1909, the first institute within a university medical faculty, Stomatology Institute du Passage Dauphine in Paris, was established to train stomatologists. Today, France has a student intake of 800 in 16 Dental Faculties and a 5 year dental curriculum. In 2006, orthodontics was the only recognized dental specialty.

Germany

The early practice of dentistry in Germany was limited by the edicts of 1685 and 1725. From 1852 only physicians were admitted to the dental examination and those approved were able to use the title "Zahnarzt". The Zahnarzte were active, publishing the first German dental journal (1846) and founding the Society of Dentists in Berlin (1847). In 1855 Eduard Albrecht, a physician and son of a Zahnarzt, opened the first government recognized dental school. Student attendance was compulsory. After Albrecht's death (1890), his clinic was absorbed into the Berlin University Medical Faculty at the University Dental Institute, and a dental school was established at the University of Leipzig and in Breslau.

There are 32 dental schools in the German Republic within the medicine faculties with the exception of the separate dental faculties in Mainz and Berlin. The 5 year course curriculum is legislated. The final examination leading to the degree of Zahnarzt, is held in the students' own university and with the university staff as examiners.

Specialist training in Germany is controlled by each Lander which confers the responsibility on the relevant chamber of dentists (Zahnarztekammer) which is also responsible for registration. Oral surgery and orthodontics are the recognized dental specialties. Unofficially, public dental health exists as a specialty.

The Netherlands

In 1877, a dental institute was established in Utrecht. There, Dr. Dentz was appointed to supervise a 4 year course. In 1947 dentistry became associated with the universities and dentistry became a sub faculty, alongside medicine, with a 6 year course: 2 years basic science, 3 years for a doctoral degree and one for the degree in dental surgery. Additional dental schools were opened in Gronigen (1947), Nymegin (1962) and in Amsterdam (1968).

Training for the two specialties recognized, orthodontics and oral surgery, are four years full-time. The training is under university regulation and registration is with a Specialist Registration Board.

Belgium

The barber surgeons were legitimized in Belgium in 1705 and, since 1818, dentists' activities have been under the medical profession's control. From 1889 all had to possess a medical qualification. The special license in dental science became compulsory in 1929, thus creating the Belgian Stomatologist.

There are six medical faculties in Belgium, each offering similar dental courses, which, since 1971, have been 5 years divided into 2 years conferring the title 'Candidat en dentaire' and three years of specialized dental study conferring the title "Licence en science dentaire". Adequate clinical training facilities present some difficulties. In Lauvain, for example, of the 100 final year students, 60 receive their clinical training in the dental school, 20 in other dental clinics and 20 with local practitioners.

The medically qualified stomatologist, orthodontist and maxillofacial surgeon are accepted as medical specialists.

Denmark

In 1909, a four year dental undergraduate course was founded in Denmark. The first dental school was opened in Copenhagen (1941). The second school was opened in Aarhus in 1959. These schools are not a part of the university. They receive a direct grant from the Ministry of Education and appointments of professors are made by the King.

The two schools co-operate on some joint clinics and lectures. Currently the student intake is 200 annually. Oral surgery training is 5 years (2 years in hospital, 2 years in the Royal College of Dentistry and one year in a hospital oral surgery department). Orthodontics training is 3 and 1/2 years, mostly in the Royal College of Dentistry and in the clinics.

Italy

Those wishing to practise dentistry required a medical qualification, prior to 1980. With Italy's entry into the EEC, a degree in 'Dentistry and Dental Prosthesis' was introduced by the faculties of medicine and surgery in 31 universities. The total first year intake was 900 in 2004. The five year course consists of 2 years basic subjects and 3 years dentistry with selection for entry dependent upon high school results and a multiple choice questionnaire (MCQ) examination.

Greece

Dental schools in Greece follow the guidelines of the Ministry of Education. There are two public schools: Athens (established 1921) and Thessaloniki (established 1950's). The course consists of 3 years of medical and 2 years of dental studies. Admission for both schools often exceeds 300 students, depending on Ministry instructions. Oral surgery and orthodontics are recognized specialities.

Portugal

Since 1911, those wishing to enter dentistry required a medical qualification. The first dental school emerged in 1976 at Oporto. Today Portugal has 3 public and 4 private dental schools. The annual intake is 600 students. The five year course (Bologna format) consists of 3 years basic subjects (Title-Licenciated in Health Sciences) and 2 years dentistry (Title-Master integrated-degree in dentistry), with selection for entry dependent upon high school results and a multiple choice questionnaire (MCQ) examination. Only one speciality, orthodontics, is recognized.

Spain

Stomatology in Spain is taught as a medical specialty and is regulated by the Medical Specialties Act which has 10 Stomatology schools. The course lasts 2 years with 2000 hours of instruction, occupying 30 hours per week between October and June.

Cover Story

Each school has 3 departments; pathology and prosthetics; medical and stomatology; orthodontics and preventive odontology. The students, who are medical graduates, are accepted as a result of MCQ tests, with 1 in 7 at present being selected.

Dental Specialist Education

Austria, Belgium, Denmark, France, Greece, Italy, the Netherlands, Portugal and Spain have few or no dental specialties. While in Iceland, Poland, Slovenia, Sweden and United Kingdom specialties are well represented. Some countries such as Estonia and Malta have many "specialists" but they are not formally recognized.

In most countries, training takes 3 - 5 years. According to the directives, applicants must have an EC approved primary dental qualification (degree). Specialty training is a minimum three years full time (or part-time equivalent) at country-specific approved institutions. Studies show wide variations in both the curricula and patterns of specialist training in orthodontics across Europe. There was also a perception of wide variations in other curricula and criteria for specialist training which led the European Federation of Periodontology to initiate a quality assurance system for postgraduate programs in periodontology in participating dental schools.

Bologna Process

In 1999, the Ministers of Education of 29 countries in the EU signed the Bologna Declaration, formally known as the European Higher Education Area. The ultimate aim of this agreement is to establish a European Higher Education Area by 2010 in which staff and students can move with ease and have mutual recognition of their qualifications. One of the objectives is that all programs become comparable in curricula and teaching.

The Bologna Process is the most important educational change in Europe in the last 50 years and the focus from universities, learned societies and thematic networks has shifted to this process with the aim of developing and achieving wide European convergence in Higher Education. With this objective, the Association for Dental Education in Europe (ADEE), together with the DentEd thematic network, obtained further funding from the European Commission for a third Network Project, DentEd 11I (2004-2007) to develop a curricular model in dentistry which is fully compliant with the principles of the Declaration of

Bologna. ADEE is a standing organization since 1975 that now represents some 150 schools out of about 200 schools in Europe.

The first step in the Bologna process is to implement the profile for the future European dentist, agreed by the General Assembly of ADEE:

The new graduating European dentist should:

- 1. Have had a broad academic and dental education and be able to function in all areas of clinical dentistry;
- 2. Be trained sufficiently in dental science;
- 3. Be able to work together with other dental and health care professionals in the health care system; should have good communicative skills;
- 4. Be prepared for life-long learning and continuing professional development;
- 5. Be able to practice evidence-based comprehensive dentistry based on a problem solving approach, using basic theoretical and practical skills.

Conclusions

It is essential that universities evaluate critically their approaches to teaching and learning. To achieve transparency at a European level an agreed terminology must be developed. Universities must not only transfer consolidated or developing knowledge but also a variety of 'general' abilities. This requires that they must explicitly develop a novel mix of approaches to teaching and learning in order to encourage - or allow to develop - valuable qualities, such as capacity for analysis and synthesis, independence of judgment, curiosity, teamwork, and ability to communicate. Changing teaching and learning approaches and objectives implies corresponding changes in assessment methods and criteria for evaluating performance. These should consider not only knowledge and contents but also general skills and competences.

Ivident - The International Virtual Dental School Sharing the Vision of a Connected Campus with the ICD

IVIDENT IS A £2.3 MILLION three year educational research project jointly funded by England's Higher Education Funding Council and the Health Department.

It aims to create a virtual dental school, providing dental education through a flexible online environment that is globally accessible. It is led by King's College London Dental Institute Deputy Director for Education FICD Dr. Patricia A Reynolds. Three UK dental schools are founding partners: University of Bristol Dental School, Queen's University of Belfast School of Dentistry and The Eastman Dental Institute, together with the University of Portsmouth.

The International Virtual Medical School provides learning resources. Ivident aims to become a self sustainable, non-profit making enterprise. Ivident bridges the gap between dental skills development and the availability of expert teachers in smaller specialties by providing a holistic learning capability with universal integration - The Flexible Learning Platform (FLP), according to Dr. Reynolds. Technically this innovative solution constitutes a "Service-Orientated Architecture" (SOA), a sort of

electronic super-glue. SOA is now available and new connected campuses are springing up. Dr. Reynolds considers ICD's intellectual resources first rate and would like the European section to participate. "By providing learning objects, a pool of some open source material can be distributed through a portal controlled by ICD, but Ivident supported. Strict quality assurance and tracking will apply so that all Ivident compliant learning objects are truly appropriate and their use measured".

Throughout the three year project (2007-2010) partner contribution is limited to their time and expertise. As Ivident will become a non profit making enterprise, further funding will be needed to reach developing countries. Already two FICD's, who are also dental school deans, have welcomed this initiative: Italy Regent Professor Corrado Paganelli, and Dr. Reinhard Hickel from Munich.

"We do not have all the answers", says Dr. Reynolds "But we do have a global problem providing high quality education and continuing education to the profession. As a very important institution in dentistry, ICD involvement can be a key factor in Ivident's development".

Dr. Aris-Petros Tripodakis

Dr. Aris-Petros Tripodakis, ICD European President gives a frank and revealing interview with ICDigest Editor about himself, family, education and the ICD.

Editor: When did you become interested in a dental career?

Both my brothers and my father were architects and I didn't want to compete with them. Indirectly, my interests focused on medicine. The admission system in the Hellenic universities and the relevant exams brought me into dentistry. From my family, I had a design background and I enjoyed working with my hands, so Prosthodontics seemed like a logical choice for further education. After I had finished a prolonged military service, I was accepted in the post graduate Prosthodontics program at Tufts University, with a year's postponement. I completed the prosthetic program with a Master's Degree and returned to Athens. I began a practice, and later worked in the University.

What did you do with your year off?

My wife and I went to Africa for ten months where we became aware of the needs of completely different cultures. For the first time, we were exposed to the joys of teaching and I understood the importance of good dental care in truly impoverished nations.

Do you find your approach to teaching different from when you attended school?

I think dental education deals with knowledge that is directly related to the patient as a human being. The dental instructor's teaching should not simply aim at the student's competence on a technique. He gives from within, and develops a personal relationship with the student in order to comply and adhere his teaching to the philosophy of treatment. Then simple training is transformed into dental education. If the instructor is formal and distant, as he could have been in the sixties, the student either automatically develops an indifferent disposition, or else is put in the difficult position of needing to interact via a less formal approach.

What then is your idea of the ideal student-teacher relationship?

Honesty, motivation and a good rapport are the ingredients of a fruitful student-teacher relationship, not aiming at just a well-trained graduating dentist, but into an educated doctor.

Would you share with us some of the things you like to do in your spare time?

During the week, all of my time is involved in treating patients, supervising lab-work, teaching, lecturing, preparing courses or working for organizations such as the ICD. During the weekends, I enjoy swimming in the sea and skiing in the mountains. I have six children from the ages of 28 to 14 and one grandchild, and I like to spend weekends and holidays cherishing my family.

What is the importance of the ICD to dentistry?

The International College is a unique organization that by virtue of its core values and mission of "recognizing service and the opportunity to serve", is truly making a difference in our profession. The core of its existence is authentic and lies within the fundamental nuclear element of human creativity, and the pursuit of service and excellence. Sharing these ideals with other colleagues leads inevitably to fellowship.

The theme of the scientific program in Athens is "The Dental Discipline in Europe in the Dawn of the New Millennium".

I will stimulate and coordinate speakers and moderators, so that the program will function as a scientific workshop worth publishing in the ICDigest.



What is the most rewarding aspect of your participation in the ICD?

The opportunity for fellowship; meeting and bonding with people worldwide who share common personal and professional values. During the annual meetings, fellowship is mainly established based on social, scientific and intellectual communication at the events, all within a friendly, relaxed and elegant atmosphere. The spouses' cohesive role is very important in creating and sustaining a feeling of family.

I know you have dental practices in both Italy and Athens. How do you manage practices in two countries?

I only have one main practice in Athens. The satellite practice, established in Rome in the early nineties, with the collaboration of two other American trained Greek specialists, was our response to the challenge that United Europe offered us. Today, after fifteen years of commuting, (always in combination with other travels) I have made Rome my home away from home. Two of my children studied in Italy, and my wife and I both speak Italian by now.

We love Italian food and music, we enjoy our Italian friends and colleagues, and I have lectured many times in Italian. As a matter of fact, although the winter Board of Regents meeting has always been organized either in Paris or London, this year we met in Rome!

Are there any special projects that you would like to concentrate on during your term as ICD President? I am excited about a proposal that was submitted two years ago in a Board of Regents meeting. It was suggested that the outcome of an ICD scientific program should not simply concentrate on continuing dental education information, but should be highly intellectual, embracing dentistry in a comprehensive way and stimulating all the participants to actively participate in prolific discussions. Short essays, discussions and conclusions will be published and become an important part of the ICD igest.

Do you see this goal coming to fruition in your term?

I was thrilled that this perspective was embraced by our Past President Phillip Dowell. He challenged the remarkable speakers in Cardiff with the general theme of "Prospective Eclecticism" and it resulted in an outstanding program. By the same token, President Elect Antonio Tavares chose "Standard of Care in Clinical Dentistry" as the 2009 meeting theme. It is also academic and comprehensive. As you see, the special project referred to in your question, has already started. The theme of the scientific program in Athens is "The Dental Discipline in Europe in the Dawn of the New Millennium". I will stimulate and coordinate speakers and moderators so that the program will function as a scientific workshop worth publishing in the ICDigest.

The meeting in Athens sounds exciting from both the scientific point of view and the social program. Is there something about Greece that you think will be a surprise to the attendees?

Indeed there is; yet, it is to be witnessed and discovered, otherwise it wouldn't be a surprise!

Three publications in the European Section are now part of an integrated communication system.

he ICD Eurogram is the newest publication of the European section. once again, this year proved to be a very positive experience for everyone who attended the International Dental Congress, held in Odessa, Ukraine from October 3-5, 2007. The title of the congress was, "Modern Achievements of Periodontology, Implantology and Osteology".

The meetings took place in two different locations: the main auditorium of the Medical University and the auditorium and teaching surgery rooms at the Academy of Medical Sciences-Department of Stomatology-Dental Research Institute.

There were many students and practicing dentists in attendance from Belarus, Egypt, Syria, India, Lithuania, Russia, Iran and Ukraine. The speakers were from such places as Germany, The Czech Republic, Israel, United States, France, Italy and of course, the two speakers presented by the European Section of the ICD and the Philip Dear Foundation, our own **Prof. Jan Van Hoeve** from Holland and **Prof. Liza Papagiannoulis** of Greece. The event was hosted by local FICD and project founder **Dr. Paul Becker** and his wife, Tania.

Prof. Jan Van Hoeve spoke on two different days. On the first day, October 4th, Jan began by giving an introduction that stressed the importance of prevention and discussed the "natural history of periodontal disease". He followed this with an in-depth lecture on "Initial".

Periodontal treatment / Hygienic phase therapy."

The following day, Professor Van Hoeve gave a half day master's class entitled "Perio Prosthetics, Diagnosis and Treatment Planning". In conjunction with this, Jan discussed the possibilities, pitfalls and tricks in periodontology and illustrated these by his marvelous personal case presentations. Needless to say, he was very much appreciated for his vast knowledge and helpful suggestions on the topic of Periodontics.

Increased ICD Presence in Eastern and Central European Countries

THERE HAS BEEN a notable increase in the number and activities of fellows in what have been called "non ICD" Central and Eastern European countries.

Seven deserving dentists from former Soviet Union countries were inducted at the annual meeting in Cardiff. In addition, Croatia, Estonia and Hungary, now have their first members in the European section. Ireland Regent, **Tom Fenney**, introduced **Dr. Piret Väli**, a General Practitioner, and Chief Dental Officer from Estonia, and the first fellow from her country. "Ireland is very proud to sponsor Piret, who has done great work for Estonian dentistry over the past ten years. I believe she will make an important resource for increasing the awareness of ICD and also find other worthy Estonian candidates". Germany's Regent **Walter Brocenbrick** brought three new fellows from Poland, distinguishing his district as the sponsor for the most number of inductees from a single non ICD country.

In recognition of the emerging activities in this part of Europe, The Board of Regents has begun to appoint Vice Regents to administer the fellows and promote local ICD activities in countries not formerly represented by a District. The current Vice Regents are **Dr. Egita Senekola** from Latvia (under the auspices of the Israel-Malta District) and **Dr. Ljubo Marion** from Slovenia (under the auspices of the Greece-Cyprus District).

Also active in the Eastern European arena is The Philip Dear Foundation, which has "the expansion" of the European Section as one of its constitutional goals. To date its most significant funding has been in the Ukraine, where a number of FICD's have traveled to Odessa to give lectures and master classes. These congresses are attended by dentists from the Ukraine as well as participants from Belarus,

Russia, Libya, Lebanon, Iran, Egypt and Italy. The program is an outcome of the agreement signed between the representatives of the Ukraine's Ministry of Health, the Academy of Medical Sciences, the Odessa Dental Institute

and the European Section of the International College of Dentists. Former Regent of Ireland and European Section Past President **Joe Lemasney**, is heading the Eastern European Committee, which has been working diligently defining how the European Section is to move forward. After a thorough report in last year's ICDigest, Dr. Lemasney presented a

discussion entitled, "Ways and Means of Extending the ICD into Central and Eastern Europe" to the Board. Following careful deliberation, the Board of Regents decided to continue with the current approach towards this part of Europe, which utilizes fellows with personal contacts to encourage potential fellowship candidates. The expressed hope is that enough individuals in a specific country, or group of countries, will be inducted, opening up the possibility of a new district.

European ICD President Aris-Petros Tripodakis is someone who has been using his contacts to make notable inroads attracting new members from Slovenia, Croatia, and Hungary. "Europe is changing", observed Dr. Tripodakis. "The West is increasingly developing the profile of the *United States of Europe*, while the East involves itself with numerous and newly inducted countries in the EC that are barely represented within the ICD fellowship. With Ljubo Marion, our Vice Regent from Slovenia, we managed to work towards improving the situation in the Central European countries".

"I am convinced that the time is right for creating a new independent region and I will do my best to fulfill this task. Moreover, I know that the new Regent for Greece and Cyprus, **Dr. Argirios Pissiotis**, has very good contacts in the dental communities of the Balkan countries of the EC such as, Bulgaria and Romania. I will encourage him to reach out to these countries".

Israel-Malta Student Award Program Enters Its 5th Year

"IN OUR DISTRICT the International College of Dentists as an organization was either unknown or misunderstood. The Student Award, which recognizes exceptional graduating dental students, provided us with a vehicle to help colleagues develop a better appreciation for the humanitarian projects and core values of the International College of Dentists", explained **Dr. Sheldon Dov Sydney**, European Section Editor and Regent for Israel-Malta.

Meet Dr. Antonio Tavares, President Elect of the European Section

n. Antonio Tavares, formerly regent for Portugal and European Section Vice President, is President Elect of the European Section, and will receive the mantle of the Presidency during the 2008 Annual Meeting Athens.

He is the founder of the Portuguese Association of Oral Implantology and Biomaterials, President of the Portuguese Society of Stomatology and Dental Medicine and The Association Stomatologique International.

a second is a professional performer, specializing in musical acting. The third is a financial instructor. His son is also a dentist, currently preparing to attend post-graduate studies in Wales, Cardiff University

Nevertheless, it is a great honor and it gives me the opportunity to work a little longer for the ICD. As a first goal of my tenure, I see reinforcing the existing Districts and gradually expanding into other countries. Just growing 'big' is not what we should strive for. In upholding numbers and quality in the existing Districts it is apparently difficult to grow fast; the past years the new vs. reduced membership ratio seems to be 1/1."

Dr. Kroon and his wife, Ineke, look forward to hosting the 2010 Annual Meeting in Maastricht, Belgium, where Frans will become President of the Section. Commenting on his selection of Maastricht, Dr. Kroon said, "I have chosen Maastricht because it is an important town for the European Community with a splendid history in old and new Europe. Considering our view towards expansion in the eastern European region, it could very well serve as a bridge to East-Europe".

Smooth Transition Anticipated for Editor



Dr. Sheldon Dov Sydney, Regent for Israel-Malta became the new Editor of the European Section with responsibility for communications, publications and the website. Sheldon, better known as "Dov," has been the Deputy Editor since 2004.

Dame Margaret Seward owes much of her interest in Dentistry to her Father's Dental practice in their home in Enfield Middx. She graduated from the London Hospital Dental School in 1959


and then went into specialty training in oral surgery.

Dame Margaret has an illustrious record of leadership and accomplishment, most recently serving as the Chief Dental Officer, Department of Health for England where she was responsible for implementing the government's strategy to modernize NHS dentistry. She is widely published and is the recipient of numerous honors, including four honorary doctorate degrees and six honorary fellowships. In 1994, she was honored as a Commander of the British Empire,

and that was followed five years later with her designation of Dame Commander of the British Empire.

In 1976, Dame Margaret became the first woman to be elected to the General Dental Council, eventually becoming President in 1994. She also served as President of the British Dental Association, Editor of the BDJ and two terms as Editor of the ICDigest. She was Vice Dean for the Royal College of Surgeons of England and served on the Board of Faculty.

Dame Margaret is now almost retired and living on the south coast of England overlooking Poole Bay. As the song from South Pacific goes, 'There is nothing like a Dame' and in terms of British Dentistry there has never been a dame like Dame Margaret.

Dr. Heinz Lässig was born in Albernau in East Germany. After finishing grammar school in 1936 he fled communist Germany to West Germany.

At the Freiburg University he studied both medicine and dentistry, later serving as assistant of the dental clinic in Freiburg with a stay at Leeds hospital. In 1964 he and his wife, Rosi, moved to Rome, where he gave training courses for dentists, later returning to his private dental office in Munich. He maintained contacts with Italy and finished his final medical examinations at the Rome University. Heinz published several scientific papers and an excellent text entitled: "Dentistry in Art and Cultural History" published at Du Mont Company. He became a Fellow of the ICD in 1981.

After the breakdown of communism, Dr. Lassig began his mission to bring modern dentistry to the eastern European countries by presenting courses in St. Petersburg and inducting the first ICD Fellows from Russia. Dr. Lassig serves diligently on the "Eastern European Committee". His excellent report on "Changes in Health Insurance in Eastern European Countries" was published in the ICDigest.

Heinz Lässig was Regent of the German section from 1993 to 2004 and in 2000 he became President of the European Section. The Annual Meeting he organized in Munich was an unforgettable experience for all of us, who had the fortune to participate.

Dr. Meropi Spyropoulos: Fellow of Note A lifetime of involvement in dental care and care for humanity

In this feature, ICDigest is pleased to highlight the activities of a Fellow of the European section whose contributions exemplify the ICD motto of "recognizing service and the opportunity to serve".



A LIFE MEMBER of the ICD and Professor Emeritus of the University of Athens, Dr. Meropi Spyropoulos has made many notable attainments over a lifetime of achievements and contributions to both profession and humanity.

Professor Meropi Spyropoulos was born and raised in

Alexandria, Egypt. She holds Dental Degrees from the Universities of Alexandria and Athens and a Master of Science in Orthodontics from the University of Michigan. For 26 years she was Professor and Head of the Department of Orthodontics at the University of Athens and she served as the Associate Dean of the Dental School, the Representative of Greece to the Standing Advisory Committee for Dental Education in Europe of the E.U., and as a member to the Erasmus Committee for the establishment of a European Program of Orthodontic Education and Specialization. She is Visiting Professor of Orthodontics at the Karolinska University in Sweden, the University of Michigan and the University of St. Louis in the USA. She is a recipient of the Harry Sicher Award of the American Association of Orthodontics for Excellence in Research.

Apart from her scientific contributions, which include two textbooks, three manuals and over 100 scientific articles on orthodontics, she has been very active outside of the profession as a member of the Council of many Greek Non-Governmental Organizations. In recognition of her many achievements and contributions to society, Dr. Meropi Spyropoulos was elected as Honorary Member of the Greek Parliament.

For over 10 years she has performed a regular, weekly broadcasting hour, on a voluntary basis and is a collaborator in numerous courses addressed to parents, organized under the auspices of the Greek Church, in Athens, Piraeus and other cities. Articles of hers concerning educational, social and behavioral matters appear often in the lay newspapers. She has been invited to lecture on topics related to problems of adolescents, young parents and lonely people in contemporary societies.

She is the author of four books of essays under the titles: *Woman is the Source* is about love, companionship, family solidarity and the role that women can play in everyday life.




DISTRICT 11 - PORTUGAL

Dr. Jadwiga Lieb Skowron





Dr. John Saville Zamet

He became a Fellow of the ICD in 1968.

John Zamet was both the first and twenty-fifth Chairman of the London Chapter of the Alpha

Omega Dental Fraternity. In 2001, he reluctantly retired from active dentistry. Always seeking a challenge, he completed an MA in Holocaust Studies and in 2007 his PhD from Oxford Brookes for a thesis on German and Austrian Refugee Dentists. He is survived by his wife Susan, son Richard, daughter Kate and one grandson.
