
Third Journalism Award for ICDIGEST Most Recent for Best Graphics

For me personally, it has been an enduring source of pride to



The ICD Tree Dr. Charles Siroky

Allow me to share with you a dream. Please open your minds and your imagination as I tell you about a tree.

This is not an ordinary tree. It is a special tree - a magical tree. In fact, it can be many trees at the same time. It is tall and stately, has strong branches and beautiful leaves. It has lovely flowers, at times,

and bears wonderful fruit. It is the ICD tree. To keep this simple, I will make my special tree - a Banyan tree. If it does not meet all of the descriptions just mentioned, remember it is a magical tree. It could just as easily be an Oak tree or a Maple or even a tall Pine tree – for in a dream they can all be special – all is magical.

My Banyan tree is now 91 years old. The seed was carefully selected by a wonderful gardener, Louis Ottofy. He had a horticulturist friend named Tsurukichi Okumura who helped him in the selection. The Council of European Dentists (CED) is a European not-for-profit association established in 1961 (originally as the EU Dental Liaison Committee) which represents over 320,000 dentists across Europe. It is composed of national dental associations and chambers from 30 European countries. Its key objectives are to promote high standards of oral health and healthcare, and effective patient-safety centred professional practice across Europe, including through regular contacts with other European organisations and EU institutions. It effectively acts as the interface between the European Institutions and the practising profession.

Apart from EU countries, the CED is open to dental associations from countries that are official candidates for EU accession, and from countries who have signed the EEA agreement. These countries may apply for observer status and this allows them to attend and participate in debates of the CED General Meetings, and to receive and exchange information under the same conditions as full members.

The CED General Meeting takes place twice a year with each country entitled to two delegates and two observers. The General Meeting is the highest decision making body of the organisation and adopts CED resolutions and other policy















positions, prepared in advance by Working Groups and Task Forces. These are composed of experts on specific issues and meet as necessary during the year.

The CED is administered by a Board of Directors, which has all the powers of administration, except those which fall within the competence of the General Meeting. There are eight Board members, including a President and Treasurer and each is elected for a period of three years and may serve a maximum of two consecutive terms.

Headquarters in Brussels

The CED headquarters is located at Avenue de la Renaissance 1, 1000 Brussels in Belgium. It is in the heart of the Brussels political area and is within walking distance of many of the important EU institutions. Its office has a staff of three, a head of office Nina Bernot from Slovenia, a policy officer and lawyer Sara Roda from Portugal and an office administrator Cathy Sauvage from Belgium.

The secretariat monitors closely the work programmes of the European Commission, the European Parliament, the Council and its subordinated bodies, the Court of Justice of the European Union, as well as of other relevant bodies. It seeks to become known to the officials of the relevant EU institutions and to be recognised as a central contact point for the profession. It is authorised to represent the CED on a day-to-day basis.

Objectives

The CED's objective is to develop and execute policy and strategy in order to:

- 1. Promote the interests of the dental profession in the EU.
- 2. Promote high standards of oral health.
- 3. Promote high standards of dentistry and dental care.
- 4. Contribute to safeguarding the protection of public health.
- 5. Monitor, analyse and follow up on all the political and legal developments and documents of the EU that involve dentists, dental care and oral health.
- 6. Actively lobby the European Institutions and Parliament, in order to serve the legal and political interests of dentists, including consumer protection issues.

To Achieve CED Objectives:

- Monitors EU political and legislative developments which have an impact on the dental profession.
- Issues policy statements and drafts amendments to proposed EU legislation so as to ensure that the views of European dentists are reflected in all EU decisions affecting them.
- Provides expertise for the EU institutions in the areas of health and consumer protection, training, safety at the work place and internal market legislation.
- Provides a platform for the exchange of information between national dental associations, and supports them in understanding the effects and implementation of EU legislation, in particular members from the new Member States and EU accession countries.
- Cooperates with all major European associations of health professionals and other liberal professions on policy issues of common interest.

Challenges Facing the CED Today

The CED Working Groups deal with a range of issues on an ongoing basis. At the present time issues such as Oral Health, Amalgam, Education and Professional Qualifications, Medical Devices, Infection Control, Patient Safety, and Tooth Whitening are high on the agenda.

Let's take two of these, Dental Amalgam and Tooth Whitening.

Dental Amalgam

The EU's mercury strategy is a comprehensive plan addressing mercury pollution both in the EU and globally and has thrown a sharp focus on dental amalgam. The EU Commission has referred to the tremendous lobby to ban mercury from remaining uses, in particular dental amalgam which, following the elimination of mercury in the chlor-alkali industry has raised to the top of the list in volume of use.

The Commission, while satisfied that dental amalgam is generally safe to use, is now concentrating very much on the environmental impact of mercury associated with dentistry. The CED has prioritised the need to act in partnership with the EU in an effort to ensure the highest standards in the handling of dental amalgam. In line with





this focus the CED in a position paper strongly states that: "The dental profession takes seriously the environmental impact of its members' activities and emphasises that the dental professional has an obligation to work within the legal framework governing mercury containing products. The CED calls on Member States to ensure the full implementation and enforcement of EU waste laws, and fully supports examination into whether this is happening."

The CED Working Group Amalgam last year completed the third in a series of surveys on the handling and disposal of dental amalgam.

This gave additional

whitening by non-dentists. the clear position of the CED's Scientific Committee on Consumer Products (SCCP) was that tooth whitening products containing between 0.1 and 6% hydrogen peroxide (H2O2) are not safe to be sold over the counter, but are safe to be used after the approval and under the supervision of a dentist.

The CED has repeatedly called for proper regulation of tooth whitening products at EU level. It therefore came as a great relief that at the Council of Ministers meeting in September 2011 the decision to amend Directive 76/768/EEC was finally taken. Now, for products containing between 0.1% and 6% hydrogen peroxide, clinical examination and first

valuable information on the trends of implementation of the Hazardous Waste Directive, and was viewed by the EU Commission as extremely helpful. The European Commission is preparing a full life-cycle study of dental amalgam in 2011 and the CED will contribute to this survey as well.

Success in Tooth Whitening Safety

Tooth whitening has caused many problems in EU countries largely because the current EU Cosmetics Directive makes it illegal for Tooth Whitening Agents with a concentration higher than 0.1% Hydrogen Peroxide to be used. This has resulted in the regulations being largely ignored throughout the EU and in the growth of tooth

treatment by a dentist will be required, after which the patient will be able to continue the treatment by him or herself. The use of these products by persons younger than 18 years will not be allowed. Tooth whitening products containing more than 6% hydrogen peroxide will continue to be prohibited.

Partnering with European Institutions

The CED was initially established to advise the European Commission and continues to take this role of an advisor and a partner to the European Institutions very seriously. The CED is a member of the European Health Policy Forum, a group of stakeholders that works with the Commission on developing new EU health policy. The CED

















also participates, together with representatives of Member States and other European healthcare associations, in the Working Group on Patient Safety and Quality of Care, the Working Group on Healthcare Professionals and the Medical Devices Expert Group.

The CED also regularly contributes to the risk assessment work of Commission-administrated scientific committees: Scientific Committee on Consumer Safety (SCCS), Scientific Committee on Health and Environmental Risks (SCHER) and Scientific Committee on Emerging and

Newly Identified Health Risks (SCENIHR). Furthermore, the CED maintains constant dialogue with the Members of the European Parliament (MEPs), particularly in connection with the Parliament's legislative work, and provides the MEPs with concrete proposals for amendments that it is hoped will be eventually reflected in final versions of European legislation.

The Cross-Border Directive

Most of the CED policy work does not consist of campaigns with clearly defined start and end dates. Rather the work is a continuous process that can go on for many years.

As an illustration, we could look at the example of the draft Directive on the implementation of patients' rights (the Cross-border Directive). This Directive has a long history, starting in the decision to exclude healthcare from the so-called Services Directive in 2006 due to the particular social value of healthcare. The CED contributed to that decision by building a strategic coalition with other European associations of healthcare professionals and by lobbying Member States, MEPs and the Commission.

When the first draft of the Cross-border Directive was presented by the Commission in the summer of 2008, the CED immediately convened a meeting of the Task Force

Internal Market, whose members met in Brussels, analysed the text of the proposal from the perspective of dentists and drafted a CED resolution on the issue. This resolution was discussed and adopted by all CED members at the next General Meeting, confirming the dentists' position on cross-border healthcare: safe and high quality dental treatment should be based on continuity of care and a strong dentist-patient relationship.

Dental treatment often requires a series of visits to the dentist to properly execute it and to provide follow-up

care, particularly in case of complications. In cases of dental tourism, when patients seek treatment abroad, the overall quality of care is difficult to ensure.

Patients should therefore have access to complete and impartial information about the possible negative consequences of receiving treatment abroad and should not be coerced or encouraged, for instance through advertisements by commercial entities promoting cheap dental tourism across the EU.

The CED position of 2008 was used as the basis for developing specific amendments within

the Task Force for the many reincarnations of the draft Directive: the European Parliament's first reading report, the Council common position and the parliamentary committee's second draft report which is currently being discussed. The CED was satisfied to see that a number of its proposals found their way into the Directive, either word for word or in principle, when the Directive was adopted in February 2011.

The adoption does not mean the end of the CED's work: it will be necessary to continue to contribute to the Commission's work in developing implementation measures for the Directive, implementing the Directive at national level, and evaluating the functioning of the Directive.

Promoting High Standards Of Oral Health and Dental Care

High standards of oral health and dental care are at the very heart of CED policy work. For instance, the CED believes that to achieve high standards of oral health in the EU the European population needs to have access to highly qualified workforce of professional dentists. To ensure this, the CED is contributing to the very important assessment of the Directive on Mutual Recognition of Professional Qualifications (Directive 2005/36/EC) and has suggested to the Commission that they update the list of study

subjects which have to be included in all European dental study programmes.

The CED believes that the list needs to include more subjects and especially subjects that are relevant today and reflect the scientific and technological progress and demographic changes of the recent years. As an example, the CED has proposed

that genetics, biomaterials and dental implantology, as well as gerodontology should be studied by every dental student in the EU.

Other key and priority areas the CED is advising on are the Bologna Process where the CED strongly opposes the implementation of the two-cycle structure (Bachelor/Master) for the dental profession and calls on academics and politicians responsible for education and health, for the protection of the public and the dental profession, to exclude dentistry from the two cycles completely.


The CED is also advising on the risks occurring from the lack of control of diplomas issued by third countries as well as by Member States; practical problems with provision of temporary cross-border services by dentists; and the development and improvement of the exchange of information between national regulatory authorities.

Code of Ethics for Dentists in the EU

The CED believes that high standards in dentistry are primarily the ethical responsibility of the individual dentists providing dental care, and through them, of professional associations. ICD Fellow Dr. Piret Vali from Estonia played a central role in updating the CED Code of Ethics for Dentists in the European Union, which was adopted in 2007 and which amended previous versions from 1965, 1982, 1998 and 2002.

The Code listed the general principles which all dentists should respect in their professional work. These principles,

including considering the patient's best interests as paramount, contributing to the wellbeing of society, and practising according to sound scientific knowledge and skills which dentists must continue updating throughout their professional lives, underpin professional codes all EU in However,




EU Manual of Dental Practice

The EU Manual of Dental Practice, commissioned by the CED, was first published in May 2004 and updated in November 2008. It is the flagship publication of the CED and one of which it is very proud. It contains an enormous amount of highly relevant information for dentists who are considering working in another country. It has been written as a practical "handbook" in which information is easy to find and understand, and is aimed at dentists, dental students, policy makers and others interested in the regulatory environment for dentistry in the EU. Quite apart from dentists intending to work abroad, it is an invaluable reference for any dentist wanting to find out information

















about any aspect of dentistry in the EU. The work was done in the main by Dr. Anthony Kravitz from Cardiff University in Wales, who was for many years a CED delegate.

The latest edition of the EU Manual of Dental Practice describes the regulations, dental training requirements, oral health systems and the organisation of dental practice in 32 European (EU and EEA) countries, including Croatia, which is due to join the EU in the near future.

The practising arrangements, the regulatory frameworks and systems within which dentists work in their respective countries are compared. There is also country specific information on the dental specialities that are recognised, along with details of where such training is available and duration. The guide also contains information on other dental care professionals, with a list of those which are recognised, their training, the procedures they are allowed to carry out, and the rules within which they can legally practise. The 2008 edition also contains (for the first time) information about tooth whitening, ionising radiation rules and hazardous waste regulations, as well as data on caries levels (in children), edentulousness and fluoridation.

Fellows Who Have Made a Difference

The current President of CED is Dr. Wolfgang Doneus from Austria. Dr. Doneus also served a previous term as President at the outset of the new restructured CED. He has represented Austria as a member of CED (EU-DLC) for many years. Dr. Orlando Monteiro da Silva from Portugal served as President and will shortly become the new President of FDI. Dr. Joe Lemasney was President of CED (then EU-DLC) and was the lead Irish delegate for over ten years. Dr. Piret Vali from Estonia has been a CED member for the past ten years and served as a Board member between 2004 and 2010.

Dr. Tom Feeney has served as Board member and treasurer for five years, and Vice-President in 1999 and continues at present as lead Irish delegate. Dr. Corrado Paganelli has represented Italy in the past; Dr. Gil Alcoforado has represented Portugal. Other ICD members to represent their countries more recently on CED include Dr. Barney Murphy from Ireland, Dr. Egita Senekola from Latvia, Dr. Erminija Guzaitiene from Lithuania, and Dr. Susanne Anderson from Denmark.

CED and the Future

The CED will proudly celebrate its 50th anniversary this year. Other European dental organisations share common subject matter with the CED but none has this essential, central and crucial political mandate. The CED core role and mandate must therefore be actively preserved and strengthened where appropriate by cooperation with other organisations, without compromising its integrity or political independence.

The core role of the CED was, is and should remain aggregating the expertise of its members on dentistry and oral health, translating it into agreed policy, and transmitting it to the European Institutions. The CED is constantly getting requests to put new issues on the agenda and one of the biggest challenges in the future will be to develop the ability to filter through the issues and then focus on the ones with the greatest potential impact on patient safety and quality of dentistry in the EU. The CED can only maintain and strengthen its voice in Brussels by providing timely and relevant input into European legislation and other initiatives.






We travel together to all Board and annual meetings and we love seeing all our good friends at least twice a year. Without her huge support I would not be able to organize the 2012 Annual Meeting.

Dr. Henrik Harmsen Becomes President Elect

Dr. Henrik Harmsen, Regent for Scandinavia was born in Copenhagen and graduated from the Royal Dental College of Copenhagen. Immediately

thereafter he did his military service, spending four months as a sergeant and another ten months as a lieutenant.

"When I started my studies in 1981, there was a huge lack of dentists, but when I graduated in 1986 unemployment rates had gone past 10%." Subsequently, Dr. Harmsen was off to Norway; a turning point in his career that led to his shift to private practice.

The "tannhelselaget clinic" which translates to "dental team clinic" was run by Jon Oedegaard who started out as a car-mechanic, then became dentist, and while doing his final exams in Munich, won the world championship in motocross. His clinic was for its day, very much in front, and being educated in Germany had taught Jon everything you ever wanted to know about articulators and function, which then and to this day is virtually unknown information in Danish dental education.

Henrik was appointed the clinic's specialist in prosthesis and bite splints, which meant long hours and evenings of reading and studying function and articulation. Jon Oedegaard was very much what you will call an eye-opener to the fact that while dentistry is, of course, about facts and where to go and what to do, it is equally as much about becoming whole as a person and a human being. There is a human being attached to the tooth!

Henrik went back to Denmark to open his own practice Slagelse, where it still is today, staffed by three dentists, one hygienist, four nurses and one accountant.

Dr. Harmsen is the fourth Danish dentist to receive the Implantology diploma at FGDP, London. His daily practice involves full mouth reconstructions, comprehensive dentistry and implantology. Continuous education has been part of his life ever since, both in Denmark and abroad. He engaged in personal development, communication and leadership-courses and ended up a coach himself.

Dr. Harmsen will host the Annual Meeting in Copenhagen, Denmark June 13-15 2013, together with his partner Ove.

Dr. Ljubo Marion Elected Vice President

The new Vice President of the European Section Dr. Ljubo Marion has served as Vice Regent for Slovenia when it was under the auspices of the Greek-



Cyprus District and as first Regent when Slovenia and six other countries joined together in forming District 14. Dr. Marion graduated from University of Ljubljana Faculty of Medicine Department Stomatology in 1968 and received his master degrees in 1976, specialist in Prosthodontics 1980 and Doctor of Science in 1985. In 2004 he received his doctorate in Dentistry and was elected lecturer in the Department of Fixed Prosthodontics, School of Dentistry, and University of Athens, where he now serves as Assistant Professor. Dr. Sydney is the first European Section Fellow to become an ICD international officer since 1999 when England's Dr. David Glynn was inducted International President.

During his service as European Section Editor, Dr. Sydney has been responsible for publication of the annual Journal the ICDIGEST, the website icd-europe.com and the e-newsletter the *ICD Eurogram*. While he will complete his term following the Munich Annual Meeting this summer, he will continue to serve as Regent for District 9 (Israel, Malta and the Baltic States).

Committee Actions

Dr. Phillip Dowell Chairs New Projects and Funding Committee

Dr. Philip Dowell was named chairman of the new projects and funding committee. This committee replaces and absorbs the previous Flexible Learning Advisory Group (FLAG). The committee will be concerned with all funding programs and coordinate with the Philip Dear Foundation and their trustees. Dr. Dowell has developed the "5S principles" which will guide the Projects and Funding Committee.

Dr. Cecil Linehan, a member of the committee and former Editor of the Section, reports on a special session of the Committee organized during the annual meeting in Vienna this past summer: "It was an opportunity for Fellows and guests to hear from three FICDs who are making significant humanitarian contributions. Almost 50 Fellows and guests attended. Dr. Miguel Pavao from Portugal is the founder of

A Smiling World, a non-governmental organization which promotes humanitarian projects in Portugal and Africa.

Dr. Vincent Lozano of Spain has worked with Dentists without Frontiers in South India for the last 15 years, under the auspices of the Vincent Ferrer Foundation cares for the poorest of the Indian populace or "dalits" also known as "untouchables". Dr. Hani Farr from Austria has over the last decade been working with his team of physicians and dentists traveling to Mexico's San Isidro Area to treat the indigenous population.

Following the presentations, there was a very lively question and answer session and an impassioned plea made by several Fellows asking that at future Annual Meetings humanitarian projects are highlighted during the Scientific Day.

Growth and Development Committee Reestablished

Following the historic creation of District 14, it was determined by the Board of Regents that the Committee on Central and Eastern Europe had done an admirable job and was no longer required. At the same time, however, the European Section continues to be very enthusiastic and retains expanding our Section beyond its current membership and nation states as a high priority. It was therefore decided to reestablish the Committee on Growth and Development under the chairmanship of Dr. Paul Gerloczy.

New President's Scientific Advisory Committee (PSAC)

At the June 2011 Board of Regents' Meeting in Vienna a President's Scientific Advisory Committee (PSAC) was established on a three year trial basis with Dr. Cecil Linehan appointed as Chair. The PSAC is intended to serve in an advice-giving capacity to the President Elect. The PSAC will also assist with securing sponsorship. Via Skype and e-mail correspondence, lengthy discussions have already been held among committee members and preliminary recommendations have been set for Annual Meetings in 2013 and 2014.



GambiaDentCare

Sustainable Primary Oral Healthcare Development in West Africa

The Republic of Gambia is the smallest and among the poorest countries in Africa. Accessible dental services are unavailable to the broader population. In 1995 Witten/Herdecke University's Oral Healthcare Project was established. Its long-term goal is

to offer a primary oral health care standard to Gambians by self-empowerment of medical personnel. Mostly native nurses are trained to provide basic dental treatment in the country's rural regions as so-called community oral health workers (COHW). The training curriculum consists of the Basic Package of Oral Care components: atraumatic restorative treatment, prevention strategies, and emergency dental care.

Project Development

In 1995, dental students from Witten/Herdecke University provided basic dental health care to the local Gambian population for the first time. There is no national dental cadre because Gambia lacks a dental school. There are fewer than ten practicing dentists, all located in the capital, Banjul, hundreds of kilometers away from rural areas. Traditional oral hygiene practices are chewing sticks. Western influences such as increased carbohydrate and processed food intake has resulted in a corresponding increase in dental caries. This is typical for African countries, where approximately 95% of carious lesions remain untreated. The GambiaDentCare Program started with the atraumatic restorative treatment (ART) technique to establish predictable restauration techiques.

Atraumatic Restorative Treatment

ART combines an atraumatic treatment technique due to a manual cavity excavation and preparation only with the use of a glass-ionomer cement as an adhesive and fluoride releasing restoration material. The clinical skills for ART



are simple and, therefore, ART can be performed by dental auxiliaries explicitly. The ART approach has become an evidence-based treatment option for dental caries in less developed countries showing a mean annual failure rate of 5% in class I cavities in recent meta-analyses.

ART has become a standard treatment for remote areas worldwide because electricity and tap water are not needed. The students' semester break was a periodic initiation that soon became insufficient. Co-operation between Witten/Herdecke University and the Gambian Secretary of State for Health allowed nurses the training to become Community Oral Health Workers (COHW). They qualified in performing ART and uncomplicated extractions without permanent supervision. Regular retraining and continuing education is provided to COHW, thus establishing continuous dental services in an additional ward of a well-known and highly frequented health center in Gambia's upper river region.

Witten/Herdecke University dental students travel



two or three times annually. Several of their working groups evaluate program effectiveness presenting a scientific basis for further development. Others work in nursery and school preventive programs and dental treatment like ART. GambiaDentCare plans to evaluate the dental caries preventive effect of salt fluoridation use in school lunches (common in Gambian nurseries and schools).

Salt Fluoridation for Prevention of Dental Caries

Social-economic development has led to an increase in dental

caries in developing countries. The lack of oral health care infrastructure means severe tooth loss, even in young people, is common. Fluoride toothpaste, a proven preventor of caries, is regularly unavailable in developing countries.

To develop effective fluoride preventive measures in Gambia, it is the aim of this randomized controlled study to evaluate the effectiveness of salt fluoridation in nursery school children to prevent dental caries over a period of 18 months. Salt fluoridation represents the most favourable cost-benefit-ratio. International project partners will replicate the resulting recommendations to other African countries with comparable oral health conditions.

People living outside urban areas often have to walk for days to reach the dentist. "At first, we did most interventions ourselves," says Dr. A. Rainer Jordan, co-founder and current project coordinator. "Patients were treated in the village square on simple wooden benches – without electricity or running water.

A specific type of caries treatment with glass ionomer cement, fortunately works without electric drills. "But soon we realized that self-help is fundamental, so we started training Gambians in basic dental treatment. Today, we focus on complicated cases which local helpers cannot handle."

Witten/Herdecke University signed an agreement with the Gambian Ministry of Health in 2008 to continue training Community Oral Health Workers in the smallest of less densely populated African states. The first training project started in the new headquarters in the provincial town of Brikama in August 2008. The former supporting point in Jahali was given to the local support association. "We helped them to help themselves. From Brikama it is much easier to reach the newly established dental units in Berending and Darsilami." Both units are close to the Senegal border, attracting Senegalese patients.

Witten/Herdecke University is establishing thirteen new dental treatment units in Gambia. One reason for Brikama's selection as the new headquarters is a kindergarten project. Dr. Jordan: "We opted for a kindergarten and a near-by primary school with 2500 children since studies show that an early start in dental care, continuous monitoring and treatment are essential to ensure long-term dental health. Hopefully the positive conditioning will be passed on to families and future generations. This would be a great success for Community Dentistry."

Oral Disease Prevention and Health Promotion in Oaxaca, Mexico


many South American countries the population suffers from a medical field shortage, including the dental field. When we first came to the region (mid 90s), we noted that private institutions provided annual dental care (only ten days) that consisted of only the most necessary and basic measures, such as simple fillings and extractions, but no dentures were provided. There are a number of reasons for this including: poor living conditions, rudimentary education, lack of access to safe water and sanitary facilities, lack of tools, equipment, infrastructure and other environmental risk factors.



Over the past twelve years, Dr. Hani Farr and his team of volunteers—Austrian doctors and local dentists—travel annually to Oaxaca, Mexico to provide free, enhanced dental care to the indigenous population.

Since oral disease is a widespread significant burden, Dr. Farr and his team are dedicated to the improvement of oral health via an action plan for promotion of an integrated prevention system.

In addition to the regular dental treatment (filling, root canal, and extraction), for the last two years their main focus

has been educational and preventative.

Introducing dental prophylaxis for children and adults was highly appreciated, especially the hygiene products provided, and the tooth brushing and cleaning instruction. Eight groups composed of ten children and one teacher visited Casa Austria Mexico-Dental Clinic daily, as well as many adults.

Supervised by volunteer doctors, dental education was offered including: the importance of regular oral check-ups in order to detect tooth decay early, gum disease prevention as the route to tooth loss prevention, early cancer screening and why all of these factors combined can affect overall health. Promoting healthy lifestyles and reducing risk factors to oral health were the main methods regarding the avoidance of emergency cases.

Our goals are to build healthy residents and communities and to promote correct oral hygiene and well-being.



Broadcasting the ICD Objective

Our International College has an objective "to foster the growth and diffusion of dental knowledge". By demystifying dentistry, we can inform and educate the public about improving their dental health.

There is a vast worldwide network of local radio stations bringing local communities together, creating an opportunity for us to be heard.

I have had the pleasure and privilege of working on the local BBC radio station in southern England for over 20 years.

An Audience of 300,000

Broadcasting to an audience of over 300,000 might seem daunting until you focus on speaking only to the person with you in the studio; then it becomes a one-to-one conversation. Your every word is under public scrutiny, but that is a daily occurrence in our practices when we are discussing treatment options with our patients. There just happen to be a few more pairs of ears!

Sometimes you will talk about a specific dental news item, such as fluoridation of the local water supply, or you may speak more generally in a phone-in format.

One lady proclaimed that gold

crowns had been superseded by platinum crowns. I gently countered that platinum is too soft a metal for the task but this was met with a fierce rebuttal: "I thought you were supposed to be a proper dentist!" After a gentle reassurance to the other 299,999 listeners about my credentials, we swiftly cut to the weather forecast. ...If you get cornered,

just change the subject.

Frequently people would ask questions which they had "not wanted to bother my dentists with". What a shame that they felt unable to ask their own dentist, but thank goodness that their local radio station provided access to a friendly dental ear.

On a Lighter Side

It can be funny when callers apparently think they are talking to only the two of us in the studio. That was a great

compliment to the sense of personal connection created by the radio station, but it was not realistic. At times, we could hear comments which would make us blush and we were sure that they had never discussed such private matters, even with their spouse! Trying to keep a British, stiff upper lip at such times can be quite a challenge, particularly when the presenter and I would be egging each other on to be the first one to dissolve in hysterical giggles on air.

This light touch was greatly appreciated by the listeners just as much as the serious message of the information.

I encourage my College colleagues to use dental news items

to speak to your local radio station in the hope that they may invite you to go on air. I am sure that, as a Fellow of this organization dedicated to education and reaching out, you will acquit yourself wonderfully, and be a credit to the ICD, while helping to demystify dentistry to the wider public.

The interest of the ICD European Section in internet-based learning was polarised by one of our European Fellows, Professor Pat Reynolds who is Director of Flexible Learning at Kings College University of London. It was Pat's address to the European Council and the wish of our section to get involved with educational and humanitarian projects that stimulated the formation of the Flag (Flexible Learning Advisory Group) committee under the original chairmanship of Dr. Cecil Linehan.

Following a meeting of this committee in late 2010, it was decided to make a number of changes to its structure and to rename it as the Projects and Funding Committee with the following pillars:

Project Recruitment

Projects can be considered to be either within our section as in the link that we have through Fellow Dr. Paul Becker with the Institute of Stomatology in Odessa, Ukraine, or outside it, like the ongoing project in Nepal. Projects can be either educational or humanitarian or indeed both and be run by individual Fellows and as we saw and heard of in Vienna from Drs. Miguel Pavao, Vincente Lozano and Hani Farr. They can also be collaborative and involve other sponsors beside the ICD and/or non-governmental organisations (NGOs) such as in the case of Nepal where there is a link with Rotary International.

FLAG

All the members of the Flag committee have been subsumed into the new P&F structure. We will continue to embrace the liaison that we have with UDente (Universal Dental e-learning) and indeed the Philip Dear Fund (PDF) has approved funding for a group led by Professor Reynolds to visit the Ukraine to set up further educational links through Udente with the Institute in Odessa during the month of October. We look forward to reporting on their work at the next European meeting in Munich, Germany in June 2012.



Fundraising

Fundraising is never easy. Currently monies go to the Philip Dear Fund (PDF) from subscriptions of each Fellow in the European section. However the annual amount is relatively small and would ideally need to the enhanced by the possibility of commercial funding opportunities. In the past money has been placed into the PDF from general funds of the European section, but this may not be sustainable.

Trust Organization

The Trust Organisation is run by the PDF Trustees in cooperation with the European Treasurer. It is of utmost importance to ensure the sustainability of projects that we undertake on a broader scale and we need to be fiscally responsible with PDF funds. It is equally important that our projects have maximum impact from a cost/benefit perspective.

The P&F Committee considered that all projects that come before it should adhere to the principles of the Five S's, which are;

- Simplicity
- Suitability
- Sustainability
- Serviced by local contact
- Supported by a written protocol

In order for the ICD to achieve its goals in education and humanitarian aid, it is essential that all Fellows feel included in being orientated towards those goals. Without you we will achieve nothing, with you the world can benefit hugely in terms of oral health. So please contact your Regent if you have a project in mind or if you envisage a way that you can help.

To quote a Chinese proverb:

- Our publications, the ICDIGEST and the ICD-Eurogram, were distributed on time to much enthusiasm. They are marked again with supreme publication and content quality within our Sections' boundaries and globally. This led to an ICD-Executive Committee decision to invite our Editor Dr. Sheldon Dov Sydney to be the Editor of the College at large and the ICD Globe.
- Expanding the College to the Eastern European Countries remains a priority, but the Board of Regents felt that the Committee on Central and Eastern Europe has accomplished its task by the formation of District 14, therefore, the Committee was discharged and reinstated the Committee on Growth and Development under the Chair of Dr. Paul Gerloczy.
- The ICD International Council met this year in New Delhi, India. Our Sections' Councilors Drs. Joe Lemasney, Frans Kroon and Argirios Pissiotis (replacing Dr. Phillip Dowell who was unable to attend) participated in the General Council sessions, as well as served as members at several Committees. Our Editor Dr. Sheldon Dov Sydney was also present in his new and well-deserved role of Editor of the College at Large.
- Congratulations to new leaders on the Board of Regents of the European Section: the election of Dr. Ljubo Marion Regent of District 14, Eastern and Central Europe as Vice President and Dr. Heraklis Goussias as Regent of District 7 Greece and Cyprus succeeding the undersigned.
